- 1) The following data categories will be processed: Family name, first name(s), sex, nationality, email address, shooter-ID, federation membership number, security clearance, other competition-related data (division, class, power factor etc.), date of birth, pictures and videos of the event.
- 2) By registering, you confirm the correctness of the data you provided.
- 3) Your data will be stored for up to 5 years after the event. Your data will be processed for the registration, computation of results, awards ceremony, administrative aspects of the competition, scoring, results lists, presentation of the event in social media and all further necessary applications relevant to the organization of such a competition. Your name, email address, shooter ID, and other relevant details will be uploaded to the relevant platforms through results lists and statistics, and therefore will be made available for download worldwide in order to grant participating shooters state-of-the-art technological access to the competition results. The organizer of the event has no control over these platforms.
- 4) You are free to object to the processing of your data at any given time. If you should make use of this revocation right, you will no longer be able to participate in the competition and your entry and participation will be cancelled by the organizer. You are free to request information regarding your personal data at any time, and you are free to amend, correct or request the deletion of any such personal data. If you should feel that the processing of your data violates the relevant data protection regulations, you are free to file a complaint with the data protection agency (<https://www.dsb.gv.at/>).
